

Ban on smoking on the CULS premises

UNOFFICIAL TRANSLATION

Article 1

Introductory provisions

- (1) This Directive applies to all components of the Czech University of Life Sciences in Prague ("CULS" henceforth) and introduces a ban on smoking and a ban on using electronic cigarettes on the main premises at the address of the seat of CULS (the "CULS Premises" henceforth).
- (2) This Directive proceeds primarily from Act No. 65/2017 Coll., Protection of Health from the Harmful Effects of Drugs, as amended by later regulations (the "Act" henceforth), and Act No. 111/1998 Coll., on Higher Education Institutions, as amended by later regulations (the "HEI" henceforth).

Article 2

Ban on smoking and ban on using electronic cigarettes

- (1) In compliance with Section 8(1)(f) of the Act, smoking is prohibited on the CULS Premises (i.e. on all internal and external CULS Premises) and in the public areas in the vicinity of CULS, excepting the public areas in the CULS Premises listed in Article 3 of this Directive.
- (2) In compliance with Section 8(2) of the Act, it is forbidden to use electronic cigarettes on the CULS Premises (i.e. in all internal and external CULS Premises) and in the public area in the vicinity of CULS, excepting the public areas in the CULS Premises listed in Article 3 of this Directive.
- (3) The premises where smoking is prohibited under para. 1 of this Article and the Act are designated at the entrance by a clearly visible graphic symbol "No smoking" in the graphic form as per the Annex A to the Act.
- (4) The premises where using of electronic cigarettes is prohibited under para. 2 of this Article and the Act are designated at the entrance by a clearly visible text informing that electronic cigarettes must not be used in the given area, in the Czech language with black block letters on a white background with the minimum size of letters 1 cm.

Article 3

Determination of public areas on the CULS Premises not subject to the smoking ban

- (1) The ban on smoking and the ban on using electric cigarettes under Article 2 of this Directive shall not apply to the public areas in the vicinity of CULS marked on the map of the CULS Premises, which forms an Annex hereto.

- (2) The areas referred to in para. 1 of this Clause hereof are identified with a clearly visible graphic symbol "Smoking allowed" in the graphic form in line with the Annex B to the Act.

Article 4
Final provisions

- (1) The Act regulates any other provisions directed at the protection of health against harmful effects of drugs under the Act, and the ban on smoking and the ban on using electronic cigarettes in other places where CULS performs its activities under the HEI.
- (2) This Directive includes an annex - a map of the CULS Premises, indicating the places of public areas that are not subject to the ban on smoking and the ban on using electronic cigarettes.
- (3) This Directive shall become valid and effective on the day of its publication.
