

# Erasmus+ your best experience

## 1. Competition organiser and competition period

The Competition organizer, Czech University of Life Sciences Prague (hereinafter referred to as "CULS"), registered office: Kamýcká 129, Praha - Suchbátka, Postal Code: 165 00, IČO: 60460709, DIČ: CZ60460709, (hereinafter referred to as "organizer" or "CULS"), organizes a photo contest called "Erasmus plus your best experience" ("Photo Contest") from 24 October 2019 to 19 November 2019 (the "Contest Period"). Details of the competition are published on the CULS website and CULS social networks.

## 2. Competition rules

These complete rules of the photo competition are published throughout the competition period on the organizer's website - in the section International Relations. The organizer is not responsible for the completeness of the extract from these competition rules, which may be published in abbreviated version on promotional or other materials in connection with the competition. These rules are considered to be the only complete and final rules of the competition.

Participation in the photo competition is voluntary and the participant by participating in the competition expresses its agreement with its rules. These rules, competition and legal relations between the organizer and competitors are governed by the laws of the Czech Republic.

## 3. Conditions of participation in the competition

Only individuals who are enrolled in full-time or part-time studies of the Bachelor's, Master's or Doctoral program at the CULS (and this study has not been interrupted) may participate in the photo contest. Each individual may participate in the photo competition only once.

In addition, all participants who do not meet the requirements of the competition or submit a photo that the organizer considers unsuitable will be excluded from the photo competition. Determining the suitability / inappropriateness of the photo is entirely the responsibility of the organizer. All contestants who do not comply with these rules or violate them in any way are excluded from the photo competition. The organizer is also entitled to decide to exclude competitors who have reason to suspect that they are using unfair, fraudulent or dishonest practices in the competition. By exclusion from the competition, the competitor loses the right to receive the prize without compensation. In addition, any competitor who submits false or fictitious data at registration or who has entered the competition more than once with altered personal details is excluded from the competition. The participant will be notified of the exclusion by e-mail, which was given at the login.

## 4. Competition schedule

- 24. 10. 2019 - 6. 11. 2019 until 12:00 - receiving photos for the photo competition
- 7. 11. 2019 - 18. 11. 2019 - publication of photographs on CULS Facebook and voting at 10:00
- 19.11.2019 publication of competition results
- December 2019 - Receipt of scholarships.

### 5. How to validly participate in the competition?

Contestants must submit at least one, but at most two photos in electronic form on the theme of Erasmus plus your best experience to kuceroaaneta@sic.czu.cz. He / she must write his / her name, surname, e-mail address, year, field of study and the name of the country where the photo was taken. By sending photos, the competitor confirms his / her agreement with the competition rules. With the photograph, only the name of the competitor will be published, which the competitor also expresses his consent by sending the photograph.

Competition photos must meet the following criteria:

- Must be a photo taken by a contest participant as part of his / her Erasmus + study abroad.
- The photo must be at least 300 dpi.
- Photos must not be vulgar or offensive.

The organizer will evaluate only photographs that meet the criteria described above and at the same time do not in any way impair the good name of the CULS. The organizer is not responsible if any from internet providers for any reason, in particular due to congestion of their network, will close access to the contest website before the contest expires, and therefore, participants using its services will cease to participate in the contest at this time. Acceptance of the photograph (s) shall be confirm by a return message, which the competitor will receive after sending his / her photograph. The organizer is not responsible if there is no return e-mail message delivered to the competitor for any reason.

### 6. Prizes

The following prizes were awarded by the organizer for this photo competition:

- 1st place 5000 CZK
- 2nd place 3000 CZK
- 3rd place 1000 CZK
- Price of the Rector of CULS CZK 3000

### 7. Voting

All photos qualifying for the photo competition will be posted in an Facebook album (@czuvpraze, Czech University of Life Sciences Prague), where fans of the site will be able to vote according to the rules described below.

The photos in the album will be sorted by the order in which they are received.

The vote will take place from 7 November 2019 to 18 November 2019 at 10:00.

The photos will be evaluated by the numbers "I like" or other emoticons ("haha", "super", "great"). The "I'm sorry" and "I'm annoyed" emotions don't count.

Votes from profiles that show duplicity or "paid voting" hits will not be counted in the contest. In the event of suspicion of any manipulation of votes for individual competitors, the Organizer is entitled, at its discretion, to exclude any of the competitors from the photo competition, even without prior notice. The CULS Rector's Prize will be selected by CULS Rector prof. Ing. Petr Sklenička, CSc.

### 8. Winner selection and conditions for winning

The first three seats will be voted on at the CULS Facebook profile (@czuvpraze, Czech University of Life Sciences Prague). Photographs with the highest number of valid votes, ie "Like" or other emotions ("haha", "super", "cool"), wins the photo.

The order is based on the number of people who voted for the photo. Votes from profiles that show duplicity or "paid voting" hits will not be counted in the contest.

The CULS Rector's Prize will be selected only by the CULS Rector prof. Ing. Petr Sklenička, CSc.

The three contestants with the highest number of valid votes and the contestants selected by the Rector of the CULS become winners.

The winner will be contacted at the e-mail address given during registration for the competition, at most twice after the evaluation of the results of the competition

19. 11. 2019. The winner must respond to an email invitation within five working days of sending the second invitation. If the winner fails to contact or refuses to take over the prize or wants to take over the prize in a manner other than that specified by the organizer, he / she loses the right to the prize and the winner becomes the next one. The next in turn will be awarded a similar or non-awarded prize and this procedure continues until the prize is awarded. If the winner cannot be identified, it will not be awarded.

The names of the winners will be published on November 19, 2019 on the CULS website (in the section International Relations) and on the CULS Facebook profile.

### 9. Rights and obligations

By sending a contest photo (s), the contestants give their consent to the CULS for their publication in the framework of the photo contest and also for any other marketing and promotional purposes. The right to win does not arise in the event of non-compliance or violation of the stipulated conditions of competition by the competitor.

The organizer reserves the right to change the competition rules without prior notice. The organizer reserves the right to terminate the competition at any time for technical, commercial or other reasons. By participation in the competition no legal entitlement to the prize is made and no winnings can be legally enforced. It is not possible to request a different price than the one set by the organizer for the respective place, resp. the Rector's Prize. The organizer is not responsible for non-delivery of the prize notification.

### 10. Consent to the processing of personal data

By participating in the competition, each competitor:

a) CULS gives its consent to the processing of personal data using its e-mail address, in order to establish contact with the competitor during the photo competition and also for the purpose of sending messages, information on the course of this photo competition and information on other marketing events of the CULS.

b) gives CULS in accordance with Act no. No. 101/2000 Coll., on the protection of personal data and amending certain acts, as amended (hereinafter referred to as the "Personal Data Protection Act") and in accordance with the General Regulation of the European Parliament and the EU Council 2016/679, on natural persons in connection with the processing of personal data and the free movement of such data - General Data Protection Regulation (hereinafter referred to as "GDPR"), consent to the processing of their personal data to the extent of name, surname, email address given to the organizer in connection in the competition or by drawing the winnings, in order to verify its valid participation in the

competition, provide the winnings in the competition and for other business and marketing purposes of the organizer for a period of 5 years; it also agrees with their publication in the extent of name, surname, year and field of study, in the media and on the CULS website, if such use is in connection with this competition, especially for the purpose of announcing the winners. At the same time, the competitor expresses his / her consent that the personal data will be processed in full and only for the above mentioned purposes also by third parties authorized by the organizer. The organizer is also entitled to assign other personal data of the competitor to these personal data. The provision of personal data is voluntary. A competitor is aware of his / her rights under Section 21 of the Personal Data Protection Act, especially if he / she discovers or believes that the organizer is processing his / her personal data that is contrary to the protection of the data subject's private and personal life or in particular, if personal data are inaccurate with regard to the purpose of their processing, they may request the addition, correction, blocking or destruction of their personal data. Upon delivery of the competitor's written request for blocking or liquidation of personal data to the organizer, the competitor is excluded from further participation in the game, including the loss of the right to hand over the prize, if delivered before its handover; The competitor may withdraw the consent at any time at the following e-mail address: [kuceroaaneta@sic.czu.cz](mailto:kuceroaaneta@sic.czu.cz).

c) if the competitor becomes a winner, he / she gives the organizer, in accordance with the relevant legal regulations, in particular the GDPR and the Personal Data Protection Act, his / her explicit consent to the use of his / her portrait, his / her written speeches his / her person or his / her personal speeches taken by the organizer in connection with the organization of the contest and the award of the prize (hereinafter referred to as the "slide") for commercial purposes on all communication media, regardless of their nature and destination, in all usual ways, modification and their possible connection with other works or inclusion in the collective work. The participant grants this consent to the organizer free of charge, without any material, time, quantity or territorial restrictions. This consent also applies to third parties to whom the organizer provides the image in accordance with its intended use.
