## METHODOLOGICAL GUIDELINE FOR ENSURING THE **STUDY**



# Ensuring the conditions of study from 25<sup>th</sup> May 2020 with respect to the coronavirus pandemic

#### Article 1

#### **Preamble**

(1) In order to prevent the spread of the infection caused by coronavirus and on the basis of Rector's Decision No. 15/2020 and in accordance with Government Resolution No. 537 of 11th May 2020 on the issuance of certain emergency measures of the Ministry of Health, this Methodical Guideline sets out recommended rules and procedures for ensuring the conditions of study at CZU.

#### Article 2

#### Conditions of Personal Presence at CZU

- (1) In accordance with Article 2 (3) of the Rector's Decision No. 15/2020, it continues to be the case that in order to verify students' knowledge and in order to provide teaching distant methods are essentially recommended. Contact forms of study should be exceptional, however are possible under the following conditions.
- (2) The physical presence of students at the study at CZU not exceed 15students in a group in met (this restriction does not apply to clinical and practical teaching and practice).
- (3) Persons participating in the contact form of study should comply with the following requirements:
  - a. he or she does not suffer from acute health problems corresponding to a viral infectious disease (e.g. fever, cough, shortness of breath, sudden loss of taste and smell, etc.),
  - b. he or she performs hand disinfection with disinfectants provided by CZU,
  - c. he or she has not been ordered a quarantine measure at that time,
  - d. the student provides a written affidavit in line with the rules of the relevant Faculty (the Faculty does not have to require an affidavit) about the absence of symptoms of a viral infectious disease in the previous two weeks,
  - e. he or she complies with the requirements for the use of protective equipment covering the nose and mouth (i.e. face masks, respirators, mouthpieces, scarves, etc.), except in cases where the number of persons (i.e. students and teachers from the academic staff) in the room does not exceed 15 and the distance between persons is at least 1.5 meters (in which case the student, participant in the admission procedure, academic staff member, member of the examination commission for the state



examination and admission procedure is not obliged to use respiratory protective equipment)

- (4) The organizer of these activities (examiner or teacher from the academic staff) is responsible for compliance with the set conditions, the student is responsible for compliance with the conditions specified in paragraph 3 of this Article, and the Faculty / Institute is responsible for providing disinfectants.
- (5) It is recommended to keep records of the time of presence of individual persons (students and staff) at each Faculty and Institute.

### Article 3 **Final Provisions**

(1) This Methodical Guideline is issued on the basis of the Rector's Decision No. 15/2020.
